Similar to Foreign Trade Zones (FTZs), the EU customs warehouse (also called bonded warehouse) program allows imported goods to be held tax- and duty-free in an authorized storage facility until they are sold in the EU community. Taxes and duties are deferred if goods are re-exported out of Europe, providing a cost-efficient way to store products until distribution is made. However, the EU places complex reporting and inventory visibility requirements on the goods' owner. E2open Duty Management helps companies comply with the rigorous requirements of various customs warehouse procedures while providing a reliable audit trail to mitigate future risk.
